"I have asthma, so I have to stay home, so I was just sewing quilts and table runners," she says. "I did not want to make (face) masks at all."

But Deb Marthaller, who manages the Playhouse Theater in Mott, asked Lisa to make 10 face masks for the crew serving takeout popcorn on Saturday nights at the theater.

"It struck me as being something I'm going to need," Deb says of the face masks.

"I said, 'OK, I'll make 10," Lisa says.

"I made her 10 and then a bunch of friends said, 'Oh, you make those?' and I said, 'No, I don't," Lisa says with a laugh.

But she reluctantly agreed to make more, as word of mouth and Facebook posts led to more requests. "And then pretty soon, I'm mailing some to New Jersey and I'm mailing some to Indiana and Minot and Fargo," she says.

Soon, her brother asked for 50 masks for coworkers at a grain elevator, and as other family and friends started asking for face masks, her "no" started turning into "yes."

"Å reluctant yes," Lisa adds.

"Doggone it, we shouldn't have to be making these. We're in the USA that's rich and has everything," she says. "Hospitals should have some. They shouldn't

GCHS graduation planned 'one way or another'

Grant County High School graduation will be held May 24, as scheduled, Principal Terry Bentz told the Elgin/New Leipzig School District board of education during its regular meeting April 15. Details, however, are still being discussed.

"We're going to have it on May 24, one way or another. We're going to have it May 24, normally or virtually," Bentz said.

High school awards night, scheduled for May 11, is also being planned in some form. "I'm still hoping

and praying we can do something with that, maybe not to the level that we used to, but maybe something. But if not, I'm trying to figure out a way to recognize those students, because they earned it. How that will look, I'm not sure," Bentz said.

With the spring extracurricular activities disrupted and distance learning in place at the school, Bentz outlined how some activities have continued, while others may still be pending. For example, Future Business Leaders of America state competitions were held virtually to determine national qualifiers.

But the N.D. High **School Activities** Association has still suspended activities indefinitely. "The board of directors will reevaluate on May 1, with the resumption of spring sports, winter basketball state tournaments, and fine arts contests to be considered only if a return to in-person K-12 instruction is imminent," the association's website states. Gov. Doug Burgum has issued guidelines for a graduated reopening process for the state Mav 1

whole thing."

"I am very impressed with our staff and how they came through during this time. They were given a week to plan this whole platform that usually takes up to a year to do something of such a drastic measure and I think they transitioned very well into this," Bentz added.

"These teachers, all of them -K-12 and paraprofessionals - all deserve our admiration and commendation for their efforts," he said.

CARES ACT FUNDS RECEIVED

During the meeting, the board learned that the district will receive approximately \$57,000 through the CARES Act. The amount was calculated based on free and reduced meal applications and enrollment. That type of funding again stresses the importance of free and reduced meal applications, Ludvigson pointed out.

"They have a big role on a lot of things here," he said.

The CARES Act funding, however, requires the district honor contracts, including those for track, golf, speech and elementary volleyball coaches, which are spring events. "Part of the

stipulation of receiving these dollars is you have to continue paying your staff under contract, and that would include our spring coaches and our bus contracts," Ludvigson said.

The board approved honoring those contracts, with the requirement that coaches still complete required training and certification.

Another COVID-19 impact has been the cancellation of the senior class trip, leaving funds in the senior class treasury that would have been spent for the trip. The board discussed various ways to disburse the funds, including dividing the funds among all the seniors in some way. A final decision was tabled until the next meeting. "We're in an abnormal situation," Ludvigson said. Under normal circumstances, the funds would not be returned to students, Bentz added.





FIRE EMERGENCY AND BURN BAN **GRANT COUNTY**, **NORTH DAKOTA** April 15, 2020

WHEREAS, the Grant County Commissioners recognize that current and forecasted dry weather conditions, combined with ample vegetation, creates a combustible formula for unnecessary fire loss and presents a risk for the citizens and property in Grant County, North Dakota; and

WHEREAS, Commissioners wish to regulate activities within Grant County which pose a potential hazard for such loss, should these weather conditions continue; and

WHEREAS, all available resources remain committed to protecting life and property; and WHEREAS, the impact of fires could threaten the health, well-being, and safety of Grant

County's citizens; and WHEREAS, the cost of response and inordinate equipment wear may be far in excess of available County resources.

THEREFORE, BE NOW, IT RESOLVED, that the Grant County Commissioners declare a Fire Emergency and Burn Ban effectively banning the starting of fires in an enclosed space, including the burning of leaves, grass clippings, garbage pits, construction debris, fallen trees, crop residue or hay land sloughs and bonfires This Fire Emergency and Burn Ban declaration is in effect when the North Dakota Rangeland Fire Danger Rating is in the High, Very High, or Extreme category and or a Red Flag Warning has been issued for Grant County, North Dakota and remains in effect until further notice. This ban includes ALL open flame manufactured or site built devices. The only exception is fully enclosed propane grills specifically designed for cooking.

THE PENALTY VIOLATION OF FOR THIS BURN BAN IS A CLASS B MISDEMEANOR (NDCC 37-17.1-10.1: MAXIMUM SENTENCE OF 30 DAYS IN JAIL AND \$1,500 FINE).

be metering them out." Lisa has sent several to a friend in Fargo, who has forwarded them to a nurse.

"Why does she not have what she needs to treat and to help?" Lisa asks.

Lisa easily found cotton material to make the face masks, diving into her stash.

"Well, I'm a fabric hoarder," she admits.

"Maybe, that's why I didn't like making them, because it was interrupting what I love and what I know how to do and I don't know how to make masks. Well, I do now. In my sleep," she shares.

Without a pattern, Lisa watched a YouTube video, then revamped the pattern slightly.

"After the 10th one, it wasn't bad," she says.

The first face masks she made were pleated with a liner inside with ties or elastic. Now, she makes fitted masks, which she can create in about half an hour.

While she had enough fabric hoarded, she did start to run out of thread and elastic.

"I think after this is all over with, I'm going to start hoarding thread and elastic, not just fabric," she says. She has ordered 30 more yards of elastic; each mask uses 20 inches of elastic, so she plans to forge ahead with more face masks.

So far, she has sewn about 100 face masks from cotton fabric, which are reportedly 60-70 percent effective, which is "better than nothing. They don't want you to use them in the hospital, but if you're going to the grocery store, it'll get you by," Lisa says.

Lisa will accept thread or elastic or money to help her purchase supplies, but she does not accept payment for the face masks themselves.



The North Dakota Game and Fish Department announces the following regulation change from amendment number one of the 2020-2022 North Dakota Fishing Proclamation.

Paddlefish Snagging Harvest Season Canceled

 The Department is canceling the upcoming paddlefish snagging harvest season due to the coronavirus pandemic.

- Paddlefish snaggers concentrate in large numbers in a small area, and often times are snagging while shoulder to shoulder making it hard to maintain proper separation.
- The amendment does allow for the possibility of a one-week snag-and-release season May 15-21. This would be two weeks later than the normal opening day with less participation expected.
- If there is a snag-and-release season, anglers would only need a fishing license.
 A paddlefish tag would not be required.







NOTICE TO PREPARE A PROGRAMMATIC ENVIRONMENTAL ASSESSMENT FOR THE GREAT PLAINS REGIONAL OFFICE'S WILDLAND SPATIAL FIRE MANAGEMENT PLAN

The United States Bureau of Indian Affairs (BIA) Great Plains Regional Office (GPRO) is preparing a programmatic en-vironmental assessment (PEA) in accordance with the National Environmental Policy Act of 1969 (NEPA) and the Council on Environmental Quality reg-ulations (40 Code of Federal Regulations [CFR]1500-1508), the Department of the Interior requirements listed in Department Manual Part 516, Chapters 1-15; BIA NEPA Handbook 2012 and Wildland Fire Policies for the development/implemen-tation of the GPRO's Wildland Spatial Fire Management Plan, implemented under the National Fire Plan, pursuant to 25 CFR Part 163.28, on trust lands located within the Great Plains Region which includes the Cheyenne River, Crow Creek, Fort Berthold, Spirt Lake, Lake Traverse, Lower Brule Pine Ridge, Rosebud, Standing Rock, Ponca, Omaha, Santee, Winnebago, and Yankton Sioux Indian Reservations and the trust lands associated with the Flandreau Santee Sioux Tribe and the Turtle Mountain Band of Chippewa in North Dakota, South Dakota, Nebraska, and Iowa. The PEA will analyze the potential impacts associ-ated with the BIA's development/implementation of the GPRO's Wildland Spatial Fire Management Plan, including wildfire suppression, urban in terface fire suppression, and the use of prescribed burning, prevention, and mechanical treat-ment as hazard fuel reduction methods. All of the land (fee and trust) within the exterior boundaries of each reservation and the trust lands associated with the Flandreau Santee Sioux Tribe and the Turtle Mountain Band of Chippewa are considered the Fire Management Planning Area by the BIA GRPO and are also known as the Project Area. The Project Area includes over 15 million acres. There is a section specific to the Standing Rock Indian Reservation, which accounts for approximately 15% of the Project Area, in the PEA.

The BIA is seeking your in-put as part of the NEPA scoping process. Comments might include reasonable alternatives, mitigation measures, probable or possible adverse impacts, and other considerations. The public comment period will begin on April 6, 2020. The BIĂ will accept written comments until close of business May 6, 2020. 
